#### Introduction

The State of Ethnic Charlotte, 2011 is the first project of the Joe Martin Institute for Inclusive Policy at the Urban League of Central Carolinas. The State of Ethnic Charlotte (SOEC) works with the Urban Institute of the University of North Carolina at Charlotte to assess the conditions and experiences of all people in the Charlotte region. The SOEC will measure ethnic progress and disparities both quantitatively and qualitatively across four Equality Index areas including economics, education, health, and social justice.

The region of interest includes the following counties in North Carolina: Cabarrus, Catawba, Gaston, Iredell, Mecklenburg, Rowan, and Union. This region also includes York County in South Carolina.

#### Methodology and Data Interpretation for Index Values

The measures from this project were adapted from the national Urban League's Black America Equality Index. The State of Ethnic Charlotte Equality Index examines the progress and disparities among the five major racial/ethnic groups in the region including Blacks, Hispanics, Asians, American Indians, and Whites as a reference group. These indicators were calculated utilizing 52 data measures in the four Equality Index areas that were available at the county level.

The Equality Index can be interpreted as the relative status of Blacks, Hispanics, Asians, and American Indians compared to Whites in the Urban League of Central Carolina's Region. For any of the four indicators, the Equality index refers to the ratio between that measure for Blacks, Hispanics, Asians, and American Indians compared to Whites. Ideally, the index should be as close to 100% as possible. Depending on the measure of interest, an index much less than or much greater than 100% suggests that the racial/ethnic minority is doing worse relative to Whites. To use college educational attainment in Cabarrus as an example, an index of 39.4%=9.3%/23.5%, where 9.3% is the percent of Hispanics with college educational attainment and 23.5% is the percent of Whites with college educational attainment. The interpretation for this index is that the percent of Hispanics in Cabarrus with college educational attainment is only 39.4% of that compared to Whites. For ease of presenting the index, indices under 100% are referred to as fractions, so 39.4% would be just below twofifths. For ease of presenting the index, indices under 100% are referred to as fractions, so 83.7% would be just over 4/5. To use another example, high school educational attainment in Cabarrus has an index of 108.7%=30.5%/28.0%, where 30.5% is the percent of Blacks with high school educational attainment and 28.0% is the percent of Whites with high school educational attainment. For ease of presenting the index, indices with a value greater than 100% were changed to a rate. The interpretation for this index is that high school educational attainment for Blacks in Cabarrus is about 1.1 times that for Whites. For this report, the greatest disparity for each county is explained.


## Special points of interest:

- Blacks had the highest rates of attaining only a high school degree or equivalent compared to Whites.
- Blacks, Hispanics and American Indians (where data was available) had much lower rates for attaining a college degree or higher compared to Whites.
- Blacks and Hispanics had lower passing scores across all counties in all reported subjects and grade levels compared to Whites.
- Overall, schools in the eight counties, region, North Carolina and South Carolina have a large minority presence.
- For most counties in the eight county region, Hispanics faired the worse out of the racial and ethnic minorities for high school graduation rate.

#### **Highest Degree: High School**

According to the U.S. Census Bureau, educational attainment refers to the highest level of education that an individual has completed. This is distinct from the level of schooling that an individual is attending. When interpreting high school educational attainment, one can view having a high school degree as being positive (i.e., not a high school dropout), but less positive when compared to those who pursue education beyond high school. Data was unavailable for American Indians in Cabarrus, Catawba, Iredell, Rowan, and Union counties.

In almost all areas studied, Blacks had the highest percent of individuals with high school educational attainment. The only exceptions were in Mecklenburg and York Counties, as well as the region, where American Indians had the highest percent.

## **Index Values for Highest Degree: High School**

- In Cabarrus County, Blacks had the highest percent of high school educational attainment at about 1.1 times that of Whites.
- In Catawba, Blacks had an attainment rate about 1.3 times that of Whites.
- In Gaston, Blacks had a rate about 1.2 times that of Whites.
- In Iredell, Blacks had a rate about 1.2 times that of Whites.
- In Mecklenburg, American Indians had a rate about 2.2 times that of Whites.
- In Rowan, Blacks had a rate about 1.1 times that of Whites.



- In Union, Blacks had a rate almost equal to that of Whites.
- In York, American Indians had a rate about 1.6 times that of Whites.
- For the ULCC region, American Indians had a rate about 1.4 times that of Whites.
- ♦ In North Carolina, Blacks had a rate about 1.2 times that of Whites.
- ♦ In South Carolina, Blacks had a rate about 1.2 times that of Whites.
- Out of all of the areas studied, American Indians had the highest rate of high school education attainment in comparison to Whites at about 2.2 times that of Whites in Mecklenburg. Hispanics had the lowest rate at slightly above two-fifths that of Whites in Rowan.

#### Highest Degree: College or Higher

For educational attainment of a college degree or higher, Hispanics had the lowest percent in the majority of counties studied. The exceptions were in Iredell and Union, where Blacks had the lowest percent and York, where American Indians had the lowest percent. Data was unavailable for American Indians in Cabarrus, Catawba, Iredell, Rowan, and Union counties.

Hispanics had the lowest average for the region at 15.0%, while Asians had the highest at 48.1%. For North and South Carolina, American Indians had the lowest percent (11.1% and 11.5% respectively) and Asians had the highest (50.9% and 47.8% respectively).

## Index Values for Highest Degree: College or Higher

- In Cabarrus County, Hispanics had the lowest percent of college educational attainment at just under 2/5 that of Whites.
- In Catawba, Hispanics had an attainment rate just above I/4 that of Whites.
- In Gaston, Hispanics had a rate just above 1/2 that of Whites.
- In Iredell, Blacks had a rate just above 2/5 that of Whites.
- In Mecklenburg, Hispanics had a rate slightly below 1/3 that of Whites.
- In Rowan, Hispanics had a rate slightly below 1/2 that of Whites.



- For the ULCC region, Hispanics had a rate slightly below 1/2 that of Whites.
- In North Carolina, American Indians had a rate slightly below 2/5 that of Whites.
- In South Carolina, American Indians had a rate slightly above 2/5 that of Whites.

#### Elementary End of Grade Scores: Math (8th Grade)

The North Carolina End-of-Grade Tests are designed to measure student performance on the goals, objectives and grade-level competencies specified in the North Carolina Standard Course of Study. Test are administered each year for Grades 3 through 8 in Math, Reading and Science. Data for York and South Carolina was unavailable. Data was unavailable for American Indians in Catawba and Iredell.

Blacks, Hispanics, and American
Indians had the lowest percentages of
passing scores in most areas. In the
region, Blacks had the lowest percent at
75.2% and Asians had the highest at 92.5%.
In North Carolina, Blacks had the lowest
at 72.1% while Asians had the highest at 93.0%.


- In Cabarrus County, American Indians had the lowest percent of passing scores at slightly above 3/4 that of Whites.

#### **Elementary End of Grade Scores: Math (4th Grade)**

In most areas studied, the percent of passing scores for North Carolina End-of-Grade Tests for 4th grade math were lower than the percent for 8th grade math. Data for York and South Carolina was unavailable. Data was unavailable for American Indians in Catawba, Iredell, and Rowan.

Blacks, Hispanics, and American Indians had the lowest percentages of passing scores in most areas. In the region, Blacks had the lowest percent at 70.9% and Whites had the highest at 91.0%. In North Carolina, Blacks had the lowest at 69.7% while Asians had the highest at 91.9%.







## Elementary End of Grade Scores: Science (8th Grade)

The North Carolina End-of-Grade Tests for Science is only given to 8th grade students. Data for York and South Carolina was unavailable. Data was unavailable for American Indians in Catawba, Iredell and Union.

Blacks and Hispanics had the lowest percentages of passing scores in most areas. In the region, Blacks had the lowest percent at 53.3% and Whites had the highest at 86.2%. In North Carolina, Blacks had the lowest at 51.8% while Whites had the highest at 85.2%.



- Out of all of the areas studied, Blacks had the lowest percent of passing scores in comparison to Whites at below 3/5 that of Whites in Union. Asians had the highest percent at about 1.1 times that of Whites in Union.

### School Enrollment (Ages 3 and Over)

School enrollment data is used in evaluation, planning, allocation of funds and measurement of compliance with Federal and State regulations. Overall, schools in the eight county, region, North Carolina and South Carolina have a large minority presence. Data was only available for American Indians at the state level and was only available for Asians at state level and a few counties.

In all areas, minority groups have higher school enrollment than Whites. One possible reason for this is due to demographic changes. In the majority of areas, Hispanics have the highest percent of children over the age of 3 enrolled in

school. However, in Gaston, Mecklenburg and York counties Blacks have higher enrollment and Asians have higher enrollment in Catawba County and North and South Carolina.

- In Mecklenburg, Blacks had a rate about 1.3 times that of Whites.


- For the ULCC region, Hispanics had a rate about 1.3 times that of Whites.
- ♦ In North Carolina, Asians had a rate about 1.4 times that of Whites.
- In all areas studied, minority groups had a higher percent of school enrollment than Whites.

#### High School Graduation Rate (4-year cohort)

For most counties in the eight county region, Hispanics faired the worse out of the racial and ethnic minorities for high school graduation rate. Asians and Whites tended to have the highest graduation rates.

In the region, Whites had the highest average graduation rate at 82.1%. Hispanics had the lowest at 59.6%. In North Carolina, Asians had the highest average graduation rate at 85.2% and Hispanics had the lowest at 61.4%.

Data was unavailable for American Indians in Catawba and Rowan counties. Data was also unavailable for York County and South Carolina.

- Out of all of the areas studied, Hispanics had the lowest graduation rate in comparison to Whites at below 2/3 that of Whites in Mecklenburg. American Indians had the highest percent at about 1.2 times that of Whites in Iredell.
